The Contractor's estimate will be evaluated to determine if the scope has been clearly and accurately understood, the work has been properly estimated with supporting data presented and that material and equipment estimates are reasonable and properly documented. The total amount quoted shall be considered the total contract price regardless of actual labor hours incurred during the performance of the project.

Please change paragraph to read:

The Contractor's estimate will be evaluated to determine if the scope has been clearly and accurately understood, the work has been properly estimated with supporting data presented and that material and equipment estimates are reasonable and properly documented. Quotes shall include a full breakdown of materials needed for the project. In addition to the material breakdown, vendor must submit any supplier quotes for any and all items quoted, but not listed on Bid Price Sheet. If vendor has indicated a percentage markup on Bid Price Sheet, this markup must be listed separately on the quote. The total amount quoted shall be considered the total contract price regardless of actual labor hours incurred during the performance of the project.

All other bid terms, conditions, and specifications as originally issued remain unchanged.
