Question #9:

The "No Rules" collection is listed on the bid which is a collection of products that have been installed in several of the schools to include the latest renovation of Oak Ridge and University High Schools. The possible issue is with the specification under the YARN systems. All of our yarn in the "No Rules" collection, to include the yarn previously approved and installed on OCPS projects, is a Nylon 6 Fiber and is a registered brand as "Eco Solution Q". If a subcontractor bids with our approved "No Rules" collection, with this be thrown out because of this issue?

Answer #9:

No. As long as the product bid meets the specifications included in the Design Guidelines DG 09 68 13 and is listed as an 'approved' product, it will be considered to be in accordance with the guidelines.

Question #10:

For line items 54-67, what grade of wood are we supposed to bid?

Answer #10:

Question #11:

For item #68 on Bid Price Sheet, is this just for installation of the wood floors?

Answer #11:

Yes. Our Design Guidelines will be updated to reflect this change with the next release.
