

Alyssa's Alert

- In honor of Alyssa Alhadeff, one of 17 victims of the tragedy at Marjory Stoneman Douglas High School
- Senate Bill 70 provides an extra layer of protection in Florida's schools.
- Schools must be outfitted with mobile panic alert systems by the start of the 2021-2022 school year.
- The systems will enable all school staff to silently and easily contact law enforcement to respond in the case of an on-campus threat or crisis.



Five Hour Required Mental Health Education

- Fully online program- Purpose Prep
- Purpose Prep was created to meet the needs of the
 5-hour requirement
- Used in multiple Florida districts, making the data transferable for students
- Lessons were delivered weekly to students
- Verification field added in FOCUS



Youth Mental Health First Aid

- Training has transitioned to a blended model
 - 2 hours delivered through self-paced online course
 - 2-4 hours delivered in person or through a virtual platform
- This year 319 staff have been successfully trained and certified in YMHFA
 - 190 of those staff completed the requirement through our Early Release Professional Development
 - Over 730 staff have been trained in YMHFA since we began providing training



Mental Health Initiatives- The Data

Universal Screener for Social Emotional Wellness


Winter = 1259, Spring = 1308

- From First Screener Identification + Intervention = Success
 - K-3: Duplicate average across schools was 40%
 - 4-5: Duplicate average across schools was 15%
- Crisis Interventions 27 (Significant Increase from 19-20)
 - October and February-April
- Threat Assessment 6 (Significant decrease from 19-20)
 - September-December and April
- MRT School Originated Calls 44, 23 just in February and March



Mental Health Initiatives:

Panorama - Actionable Data and Insight into The Whole Child, School and District



- Student Success
 - Fully integrated MTSS platform, Increased Efficiency = Increased time for students
 - Identification = Prevention, Intervention + Analysis = Success
- Student SEL
 - Complete social emotional wellness screener developed by Harvard University
- Adult SEL
 - Complete wellness, school climate and efficacy measure developed by Harvard University
- Family Feedback Surveys
 - Complete survey & communication feedback system for families & community



Mental Health Initiatives

- Boys and Girls Club Out of School Time (KW and BPK), pilot and then expand
- CHI Expanded psychiatric and mental health services
 - referral system developed just for MCSD
- DAPPS Developing monthly SEL themes for 21-22
 - Student, teacher and parent components for a whole child effort
 - Themes derived from school climate survey from the fall
 - USF completing qualitative data analysis of 3206 student comments from screener
 - Updating all MTSS materials and embedding restorative practices into prevention and response protocols
- GCC Lunch and Learns on Suicide Prevention ~160 community participants
- Making updates to district Crisis Intervention and Behavioral Threat Assessment paperwork
- Ensuring School Counselors and School Social Workers have monthly behavior and mental health data chats with GCC, MFLC and other agencies
 - Supports coordination of care and school-community connection
- Visiting all schools to talk directly to students about what worked, what did not work, what they like and what
 we could do better when it comes to their social and emotional wellness...letting them know their
 voice matters
