CONTRACT RENEWAL

- 2. The Renewed Contract shall commence on November 17, 2021 and expire on November 16, 2022.
- 3. All other terms and conditions of the Original Contract shall remain in full force and effect.
- 4. Contractor's obligations to maintain insurance remains in effect as evident by the updated copy attached.
- 5. Contractor hereby certifies that the Relationship Disclosure Affidavit and Debarment Certification as submitted as attachments to the Original contract have remained unchanged or has submitted new documents as necessary.
- 6. Beginning January 1, 2021, all contractors doing business with the Monroe County School District shall be required to provide proof of enrollment in the E-Verify system. Contractor shall be required to insure compliance with all applicable E-Verify requirements, including screening all employees to verify their work authorization status. If Contractor enters into any contract with a subcontractor, Contractor shall be required to obtain an affidavit from the subcontractor confirming that the subcontractor does not employ, contract with, or subcontract with any person who is not authorized under federal law to be employed in the United States. Contractor shall be required to maintain a copy of said affidavit for the duration of the Contract Term.
- 7. NOTE: A copy of the original contract must accompany this renewal.
